### **Belinda Burne**, Partner

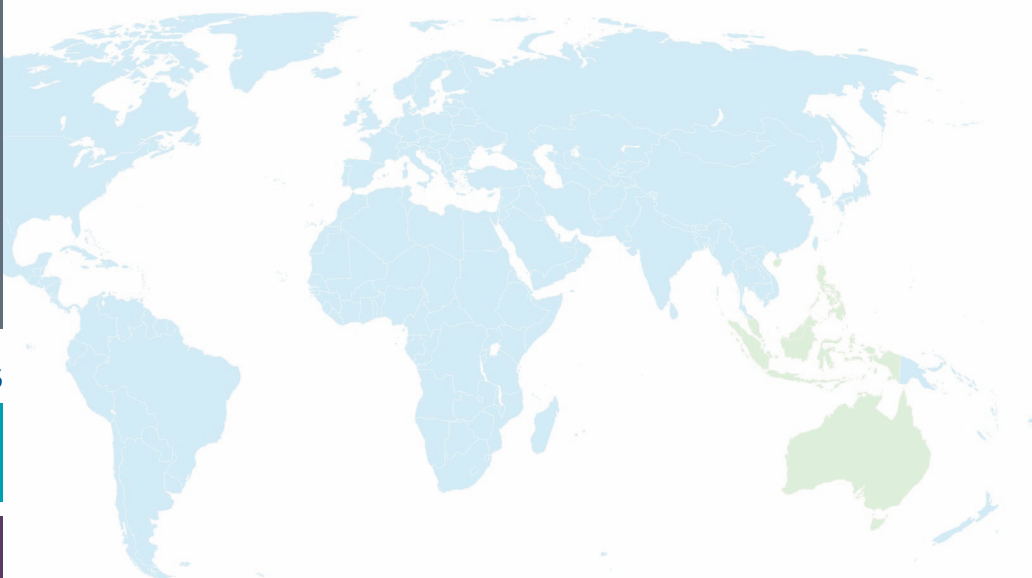
